**BAC Resolution Recommending to the HOPE for Cancellation of Bidding for
 the Supply and Delivery of Various Food Items for Supplementary Feeding
 Program for the Province of Surigao del Norte**

RESOLUTION NO. 011-2019

WHEREAS, the Department of Social Welfare and Development posted the Invitation to Bid for the above-mentioned project, in DSWD Caraga Region website, the PhilGEPS and at the conspicuous places / premises of the Department of Social Welfare and Development dated May 7, 2019;

WHEREAS, the posting of this advertisement are parted into ten (10) lots with its corresponding Approved Budget for the Contract (ABC) on a per lot basis, to wit:

WHEREAS, the BAC conducted a Pre-Bid Conference dated May 15, 2019 at 2 o'clock in the afternoon and some clarifications and concerns were raised by the prospective bidders. One of the issues is the posted clustering per lot as indicated above that composed of two (2) to three (3) municipalities. The said clustering will cause some difficulties to local suppliers when the implementation period of the project comes, which are as follows: 1) the topography and distance among the posted clustered municipalities varies; 2) limited financial capacity of the local supplier considering the number of municipalities per cluster; and 3) limited network and manpower to implement the contract as stipulated in the Bidding Documents should the posted clustering will be observed;

WHEREAS, based on the foregoing cited reasons, the prospective bidders requested to BAC to change the component of lot posted in the Invitation to Bid (ITB) from clustered municipalities to per municipality and conduct reposting of advertisement reflecting the said changes in order to


have a wide opportunity of local suppliers who are legally, technically capable but with limited financial capacity to participate in the bidding procurement;

WHEREAS, upon hearing the areas of concerns raised, the BAC decided in quorum during the pre-bid conference to change the component of lot and new ITB will be post immediately reflecting the lot component per municipality;


WHEREAS, changes the lot component required at the same time to change the ABC per lot. GPPB Resolution No. 07-2005 dated April 1, 2005 states that if the ABC is adjusted either upwards or downwards, the procuring entity must conduct re-bidding with re-advertisement/posting of the project and must reflect the adjusted ABC in the re-advertisement;


NOW, Therefore, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare the **CANCELLATION OF BIDDING** of the said project based on the foregoing provisions and conduct re-advertisement/posting reflecting the adjusted ABC in the ITB.


