

CONTRACT AGREEMENT
No. 2022 - 011

THIS AGREEMENT made the 19~~th~~ day of January 2022 between **Department of Social Welfare and Development Field Office Caraga**, Capitol Site, Butuan City Philippines (hereinafter called "the Entity") of the one part and **ISENGARD SECURITY AGENCY** of 2nd Floor, Butuan City Rural Bank Building, A.D. Curato Street, Butuan City,, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT OF SECURITY SERVICES FOR C.Y. 2022** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THREE MILLION TWO HUNDRED SIXTY-EIGHT THOUSAND SEVENTY NINE PESOS AND TEN CENTS ONLY (Php3,268,079.10)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation, to wit:
