BAC Resolution Declaring Failure of Bidding

Resolution No. 013-2022

WHEREAS, the Department of Social Welfare and Development – Field Office Caraga posted the Invitation to Bid for the bidding project **PROCUREMENT OF WELFARE GOODS (RAW MATERIALS) FOR STOCKPILING – LOT 1: PROCUREMENT OF CORNED BEEF, CANNED TUNA FLAKES IN OIL, AND SARDINES** in the PhilGEPS Website, DSWD Website, and at the conspicuous place at the premises of the DSWD Caraga (BAC Bulletin Board) on August 15, 2022;

WHEREAS, the Approved Budget for the Contract for the said lot is **THREE MILLION FIVE HUNDRED NINETY-ONE THOUSAND PESOS ONLY (PHP3,591,000.00)**;

WHEREAS, in response to the said advertisement, four (4) bidders purchased bid documents and/or submitted bids on the set deadline of September 5, 2022 at 1:30 p.m. – Diamond Supply Chain Solutions Corporation, EJ & JY Wet Market and Enterprises, Bodeguita Enterprises and Services, and Fraynn General Merchandise;

WHEREAS, on September 5, 2021, after preliminary examination of the bids, the BAC, using non – discretionary “pass/fail” criteria, the BAC determined the bids of Diamond Supply Chain Solutions Corporation and Fraynn General Merchandise as “failed” due to non-compliance to the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, during the said preliminary examination of the bids, the BAC declared the bids of EJ & JY Wet Market and Enterprises and Bodeguita Enterprises and Services as “passed” for complying with the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, the Bids and Awards Committee (BAC) through its Resolution No. 017 - 2022 on September 6, 2022 resolved to the conduct of post-qualification evaluation to **EJ & JY WET MARKET AND ENTERPRISES** declared as having the **Lowest Calculated Bid (LCB)**, to examine further its responsiveness to the project **PROCUREMENT OF WELFARE GOODS (RAW MATERIALS) FOR STOCKPILING – LOT 1: PROCUREMENT OF CORNED BEEF, CANNED TUNA FLAKES IN OIL AND CANNED SARDINES**;

WHEREAS, the Bids and Awards Committee (BAC) through its Resolution No. 021- 2022 on September 19, 2022 resolved to declare EJ & JY Wet Market and Enterprises as **Post – Disqualified** and resolved to the conduct of post-qualification evaluation to Bodeguita Enterprises and Services as having the next **Lowest Calculated Bid** for the project **PROCUREMENT OF WELFARE GOODS (RAW MATERIALS) FOR STOCKPILING – LOT**

1: PROCUREMENT OF CORNED BEEF, CANNED TUNA FLAKES IN OIL AND CANNED SARDINES;

WHEREAS, after thorough verification, validation and ascertainment of all statements and documents submitted by Bodeguita Enterprises and Enterprises, using non – discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of the said bidder is inconsistent with the prescribed contents in the Bidding Documents, particularly in Section VII. Technical Specifications;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to declare **FAILURE OF BIDDING** for the project **PROCUREMENT OF WELFARE GOODS (RAW MATERIALS) FOR STOCKPILING – LOT 1: PROCUREMENT OF CORNED BEEF, CANNED TUNA FLAKES IN OIL AND CANNED SARDINES.**
