

**CONTRACT AGREEMENT**  
**No. 2023-022**

**KNOW ALL MEN BY THESE PRESENTS:**

This Agreement made and entered into this 6th day of September 2023 at Butuan City, Agusan del Norte, Philippines between and among:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a National Agency of the Republic of the Philippines, with office address at Batasan Pambansa Complex, Diliman, Quezon City herein represented by **MARI-FLOR A. DOLLAGA – LIBANG**, in her capacity as Regional Director of **FIELD OFFICE CARAGA**, hereinafter referred to as the “**Procuring Entity**”;

**AND**

**FAS TRUCKING AND FORWARDING SERVICES**, a duly licensed private entity, organized and existing by virtue of the laws of the Republic of the Philippines, with office address at Purok 5, Brgy. Doongan (Lower), Butuan City, Philippines represented by **JENELITO Y. FERNANDEZ**, Proprietor, hereinafter referred to as the “**Service Provider**”;

**WITNESSETH**

WHEREAS, the Procuring Entity invited Bids for the **PROCUREMENT OF FORWARDING SERVICES FOR THE HAULING OF HUMANITARIAN CARGO** and has accepted the Bid of the Service Provider for the provision of forwarding services in the sum of **SIX MILLION FIVE HUNDRED FIFTEEN THOUSAND PESOS ONLY (PhP6,515,000.00)** (hereinafter called “the Contract Price”);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - a) Schedule of Requirements;
    - b) Technical Specifications;
    - c) General and Special Conditions of Contract; and
    - d) Supplemental or Bid Bulletins, if any;
  - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation, to wit:

3. In consideration for the sum of **SIX MILLION FIVE HUNDRED FIFTEEN THOUSAND PESOS ONLY (Php6,515,000.00)**, or such other sums as may be ascertained, **FAS TRUCKING AND FORWARDING SERVICES** agrees to supply/deliver/perform for the **PROCUREMENT OF FORWARDING SERVICES FOR THE HAULING OF HUMANITARIAN CARGO** in accordance with its Bid.
4. The Department of Social Welfare and Development Field Office Caraga agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




