# CONTRACT AGREEMENT No. 2023-023

## KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into this \_\_\_\_\_\_ day of October 2023 at Butuan City, Agusan del Norte, Philippines between and among:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT,** a National Agency of the Republic of the Philippines, with office address at Batasan Pambansa Complex, Diliman, Quezon City herein represented by **MARI-FLOR A. DOLLAGA-LIBANG** in her capacity as Regional Director of **FIELD OFFICE CARAGA**, hereinafter referred to as the "**Entity**";

#### AND

**BODEGUITA ENTERPRISES AND SERVICES**, a duly licensed private entity, organized and existing by virtue of the laws of the Republic of the Philippines with office address at St. Anthony Bldg., Lopez Jaena St., Bacolod City, Philippines, represented by **ROMAN C. DEL FIERRO**, Authorized Representative, hereinafter referred to as the "**Supplier**";

#### WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly PROCUREMENT OF RICE VACUUM BAGS AND SCOTCH TAPE FOR PACKING OF RICE AND FAMILY FOOD PACKS and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of ONE MILLION FIVE HUNDRED SEVENTY-EIGHT THOUSAND ONE HUNDRED PESOS ONLY (PhP1,578,100.00) (hereinafter called "the Contract Price").

**NOW THEREFORE**, for and in consideration of the foregoing premise and mutual terms, conditions and stipulations hereinafter set forth, the parties do hereby agree:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation, to wit:

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of ONE MILLION FIVE HUNDRED SEVENTY-EIGHT THOUSAND ONE HUNDRED PESOS ONLY (PhP1,578,100.00) or such other sums as may be ascertained, BODEGUITA ENTERPRISES AND SERVICES agrees to supply/deliver/perform for the PROCUREMENT OF RICE VACUUM BAGS AND SCOTCH TAPE FOR PACKING OF RICE AND FAMILY FOOD PACKS in accordance with his Bid.
- 4. The Department of Social Welfare and Development Field Office Caraga agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
