JOB DESCRIPTION:

Under the direct supervision of the Unit Head, will be in-charge for the implementation of the programs and inter-agency collaboration on women, family and community/special concerns.

Functions and Responsibilities:

1. Implement and monitor project activities along the following sectors:
 - Older Persons
 - LGBTQIA+
 - Persons of Concern (Asylum Seekers, Refugees, etc.)
2. Assist in the implementation of the programs for People Living with HIV, Yakap Bayan, SWD Monitoring of Laws and other sectors, as assigned by the Supervisor.
3. Assist, facilitate and document the conduct of workshops, trainings, advocacy sessions, meetings and other program activities as necessary;
4. Coordinate with the Local Government Units, Non-Government Organizations, People's Organizations, Regional Line Agencies and other local partners for partnership and collaboration;
5. Attend meetings/conferences/advocacy events and similar activities in relation to the implementation of programs/services along these sectors;
