

CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into this 08th day of December 2023 at Butuan City, Agusan del Norte, Philippines between and among:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a National Agency of the Republic of the Philippines, with office address at Batasan Pambansa Complex, Diliman, Quezon City herein represented by **MARI-FLOR A. DOLLAGA-LIBANG** in her capacity as Regional Director of **FIELD OFFICE CARAGA**, hereinafter referred to as the **"Entity"**;

AND

XITRIX COMPUTER CORPORATION, a duly licensed private entity, organized and existing by virtue of the laws of the Republic of the Philippines with office address at 23 Detroit St., Cubao, Quezon City, Philippines, represented by **JOEL C. SIA**, President, hereinafter referred to as the **"Supplier"**;

WITNESSETH

 4. The Department of Social Welfare and Development Field Office Caraga agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
