WHEREAS, the Department of Social Welfare and Development posted the Invitation to Bid for the project PROVISION OF DEDICATED INTERNET ACCESS (DIA) FOR DSWD FIELD OFFICE CARAGA REGIONAL OFFICE AND INTERNET CONNECTIVITY FOR SUBREGIONAL OFFICES (SECONDARY ISP) on the DSWD Caraga Region website, the PhilGEPS and at the conspicuous places/premises of the Department of Social Welfare and Development dated May 09, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) for the said-mentioned project and the awarding of the contract is Five Million Five Hundred Thousand Three Hundred Sixty Eight Pesos Only (Php 5,500,368.00);

WHEREAS, no bidders purchased the bidding documents and participated on the scheduled Opening of Bids on May 29, 2024;

WHEREAS, Section 35.2 of the same Act provides that in order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;
